EXHIBIT "A"

Part of the NE 1/4 of the NW 1/4 of Section 2, Township 20 South, Range 3 West, Shelby County, Alabama, said part being more particularly described as follows: Begin at the SE corner of said 1/4-1/4 section and run in a Northerly direction along the East line of said 1/4-1/4 line for a distance of 240.0 feet; thence turn an angle 73 deg. 13 min. 02 sec. to the left and run in a Northwesterly direction for a distance of 237.06 feet to a point on the Southeasterly right of way line of Elizabeth Street; thence turn an angle of 75 deg. 57 min. 07 sec. to the left and run in a Southwesterly direction along the said right of way line for a distance of 147.29 feet to the point of curve of a curve to the left; said curve being concave in a Westerly direction having a radius of 15 feet and a central angle of 92 deg. 19 min. 51 sec.; thence run along the arc of said curve in a Southeasterly direction for a distance of 24.17 feet to the end of the curve; said point being on the Northeasterly right of way line of Royal Lane; thence run in a Southeasterly direction along said right of way line for a distance of 337.64 feet to point of beginning; being situated in Shelby County, Alabama.
