The Court having considered all the evidence presented enters Order as follows:

1.) By stipulation of the Plaintiff and Defendant Barnes and Associates, Inc., the Court finds that the Plaintiff's interest and lien in Lot 2, according to the survey of Countryside, as recorded in Map Book 7, Page 19, in the Probate Office of Shelby County is superior to the interest of said Defendant Barnes and Associates, Inc.

2.) By stipulation of the Plaintiff and Defendants Mayfus R. Bird and James W. Bird, the Court finds that the said Defendants' interest and lien in Lot 2, according to the survey of Countryside, as recorded in Map Book 7, Page 19, in the Probate Office of Shelby County is superior to the interest of the Plaintiff.

3.) Judgment by proof is entered for the Plaintiff and against the Defendants Horace Harvill and Star Development Company, a corporation in the sum of \$ 1619.40 and costs of court.

4.) Judgment by default is entered for the Plaintiff and against the Defendants Levin Smith and Vanessa Smith in the sum of \$ 1619.40 and costs of court.

5.) A Mechanic's and Materialmen's lien is fixed and established on the building or dwelling house and the improvements thereon situated upon the real property situated in Shelby County, Alabama described as Lot 2, according to the survey of Countryside, as recorded in Map Book 7, Page 19, in the Probate Office of Shelby County, Alabama.

Further, the Court Orders that the above described property, together with the improvements thereon, be condemned to satisfy the judgment rendered in favor of the Plaintiff and that said real property

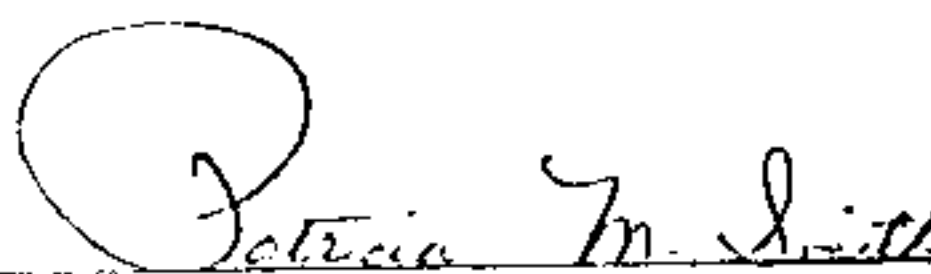

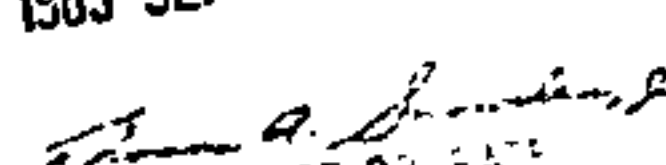
