Conrad Willmon, do hereby certify that, by unanimous vote of the directors then in office, on Friday, August 12, 1983, resolutions were adopted to amend the Articles of Incorporation filed with the office of the Probate Judge of Shelby County, Alabama, on April 5, 1983, as follows:

"1. BE IT RESOLVED that, effective immediately, the name of this corporation shall be changed from Better Business Associations of America, Inc. to Business Protection Associations of America, Inc., and

"2. BE IT FURTHER RESOLVED that, effective immediately, the address of the corporation's registered office and address of the corporation's registered agent be changed from 2163 Highway 31 South, Pelham, AL 35124 to 1422 Montevallo Road, P. O. Box 527, Alabaster, AL 35007."
