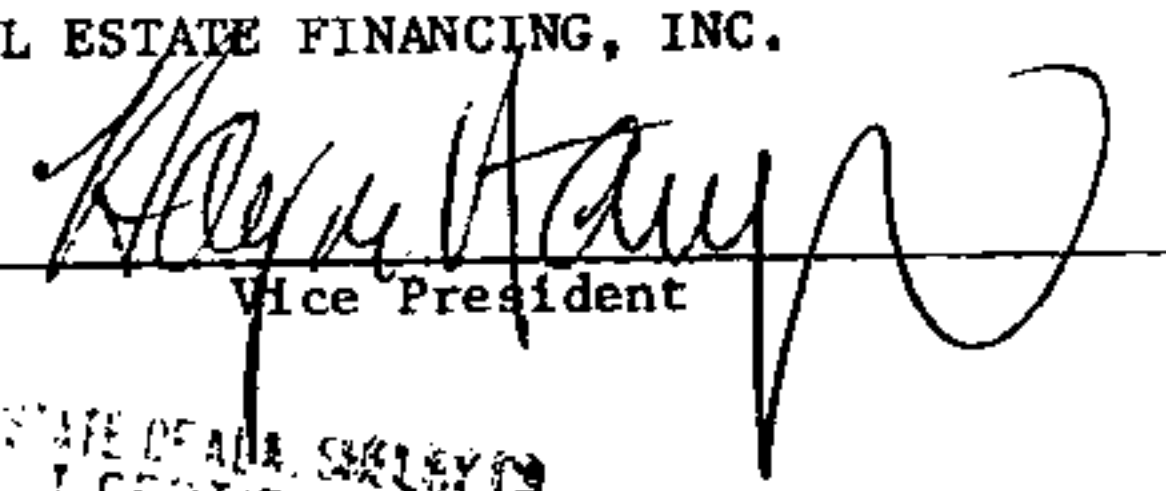

It is specifically understood and agreed that this assignment is made without recourse on the undersigned.

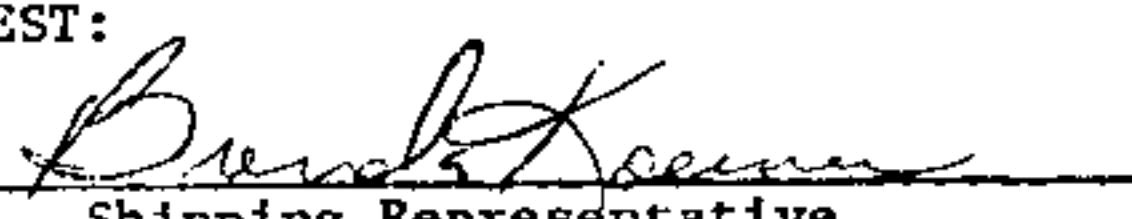
