ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of a corporation under the Code of Alabama, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is M & H Equipment Company, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: To own, sell, lease, rent, repair and service equipment of any nature, and any other purpose allowed this corporation by the Code of Alabama.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000), at One Dollar (\$1.00) par value per share. There is only one class of stock.
