

Commence at the Southwest corner of the Northwest quarter of the Northeast quarter of Section 36, Township 19 South, Range 3 West, Shelby County, Alabama, thence run Easterly along the South line of said quarter-quarter a distance of 206.0' to a point, Thence turn an angle of 38 degrees 15 minutes to the Left and run Northeasterly a distance of 350.0' to a point, Thence turn an angle of 87 degrees 59 minutes 15 seconds to the Left and run Northwesterly a distance of 20.62' to a point on the North right of way line of Valleydale Road, Thence turn an angle of 88 degrees 23 minutes 01 second to the Right and run Northeasterly along said right of way line a distance of 40.0' to the point of beginning of the property being described, Thence continue along last described course a distance of 198.76' to a point, Thence turn an angle of 88 degrees 23 minutes 01 seconds to the Left and run Northwesterly a distance of 200.0' to a point, Thence turn an angle of 90 degrees 0 minutes to the Left and run Southwesterly a distance of 219.10' to a point, Thence turn an angle of 90 degrees 0 minutes to the Left and run Southeasterly a distance of 161.12' to a point, Thence turn an angle of 27 degrees 12 minutes 16 seconds to the Left and run Southeasterly a distance of 43.71' to the point of beginning, containing 1.0 acre.

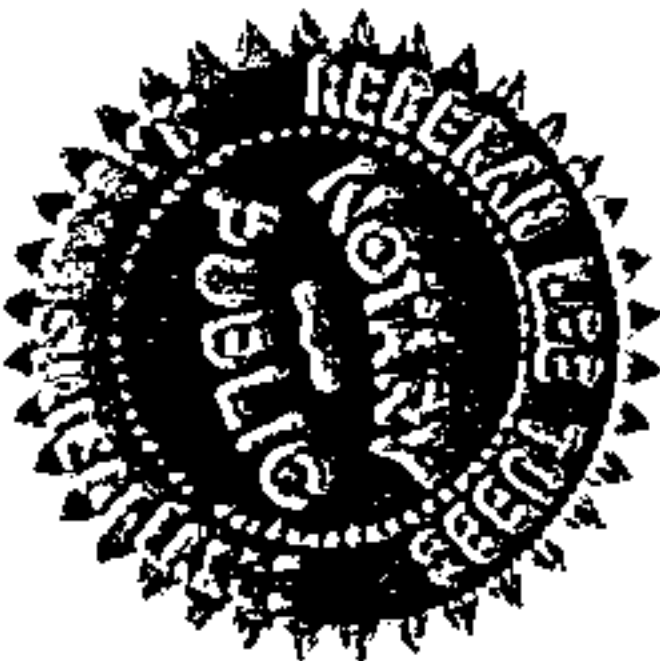
