

PARTIAL RELEASE FROM MORTGAGE

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, the First National Bank of Birmingham now known as AmSouth (Mortgagee) does hold that certain mortgage executed by Robert L. Robinson, Bagby Elevator Co., Inc. and Charles B. Morgan known as the Partnership (Mortgagors)

To have and to hold the same unto the said Partnership, and assigns or transferees, forever, freed and discharged of and from the lien of said mortgage, and every part thereof; Provided always nevertheless, that nothing therein contained shall in any way impair, alter or diminish the effect, lien or encumbrance of the aforesaid mortgage on the remaining part of said mortgaged property, not hereby released therefrom, or any of the rights and remedies of the holder hereof.
