RESOLUTION PASSED BY THE  
SHELBY BAPTIST CHURCH, INC.

ON THE 13TH DAY OF NOVEMBER, 1983

WHEREAS, Shelby Baptist Church, Inc. located in Pelham, Alabama, organized under the incorporation laws of the State of Alabama, desires to partially pay the cost of constructing a new worship and educational facility in order to sufficiently care for its membership; and

WHEREAS, to partially pay the cost of constructing a new worship and educational facility, it becomes necessary for said Church to borrow the sum of TWO HUNDRED TWENTY-FIVE THOUSAND AND NO/100TH DOLLARS (\$225,000.00) plus interest and closing expenses from the First Bank of Alabaster, Alabaster, Alabama; and

WHEREAS, in order to borrow said money from said bank it is the desire of said Church to secure the lender; and

WHEREAS, to secure said Lender it becomes necessary to place on-certain real property owned by said Church situated in Shelby County, Alabama, a mortgage, a more particularly description is as follows:

A parcel of land located in the N $\frac{1}{2}$  of SE $\frac{1}{4}$ , Section 11, Township 20 South, Range 3 West, as shown by plat of Shelby Baptist Church Survey as recorded in Map Book 8 Page 148 in the Probate Office of Shelby County, Alabama, and being more particularly described as follows: Commence at the Southwest corner of the NW $\frac{1}{4}$  of SE $\frac{1}{4}$ , Section 11, Township 20 South, Range 3 West and run thence North along the West line of said  $\frac{1}{4}$ - $\frac{1}{4}$  a distance of 123.87 feet to the point of beginning; thence continue North along said West line of said  $\frac{1}{4}$ - $\frac{1}{4}$  a distance of 300.0 feet to a point;

thence turn an angle of 91 deg. 17 min. 14 sec. to the right and run Easterly a distance of 1323.33 feet to a point; thence turn an angle of 82 deg. 50 min. 47 sec. to the left and run northeasterly 358.45 feet to a point on Bearden Road; thence turn an angle of 140 deg. 21 min. 03 sec. right, a distance of 62.45 feet; thence turn an angle of 90 deg. to the left and run 10.0 feet; thence turn an angle of 90 deg. to the right and run along the Westerly ROW line of said Bearden road a distance of 721.22 feet to a point; thence turn an angle to the right of 122 deg. 29 min. 46 sec. and run Westerly a distance of 1790.68 feet to the point of beginning; being situated in Shelby County, Alabama.

WHEREAS, it is the desire of said Church to authorize and empower the Board of Trustees of said Church with such powers as are necessary to accomplish the above enumerated desires.

NOW, THEREFORE BE IT RESOLVED that the Board of Trustees of Shelby Baptist Church, Inc., located in Pelham, Alabama be and they are hereby authorized to place a Mortgage on certain real estate owned by said Church, a more particularly description hereinabove described, in an amount not to exceed TWO HUNDRED TWENTY-FIVE THOUSAND AND NO/100TH DOLLARS (\$225,000.00) at an interest rate not to exceed TWELVE AND 50/100TH PERCENT (12.50%) per annum.

BE IT FURTHER RESOLVED THAT THE said mortgage shall be signed in the name of and on behalf of Shelby Baptist Church, Inc. located in Pelham, Alabama, by its Chairman of the Board of Trustees and attested by the Secretary of the Board of Trustees of said Church.
