ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
FIRST REAL ESTATE CORPORATION OF ALABAMA

Frederick W. Ulbricht, Donald Ray Murphy, Roy L. Martin and Ferrell Wood, being all of the Stockholders and Directors of the Corporation, do hereby amend the Articles of Incorporation heretofore filed in Corporation Book 11, at Page 610, as follows:

Paragraph 5 is deleted and the following substituted therefor:

"The total number of shares of stock which the corporation shall have the authority to issue shall be 1,000,000 shares of common stock of the par value of \$1.00 per share."

The outstanding 800 shares of stock with a par value of \$5.00 per share are to be recalled and 80,000 shares at a par value of \$1.00 per share issued in their stead. Stated capital will thus be increased to \$80,000.00.

The number of shares outstanding is 800, and the number of shares entitled to vote thereon is 800. All 800 shares voted for the amendment, and no shares voted against.

The amendment was adopted at a special meeting of the Stockholders and Directors on *August 1*, 1981.

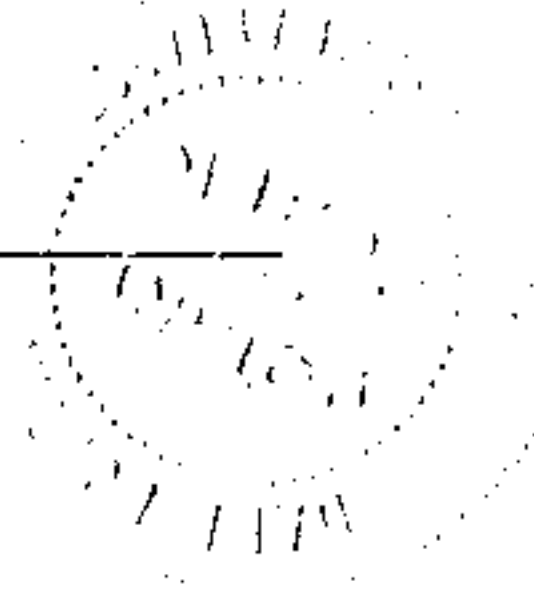

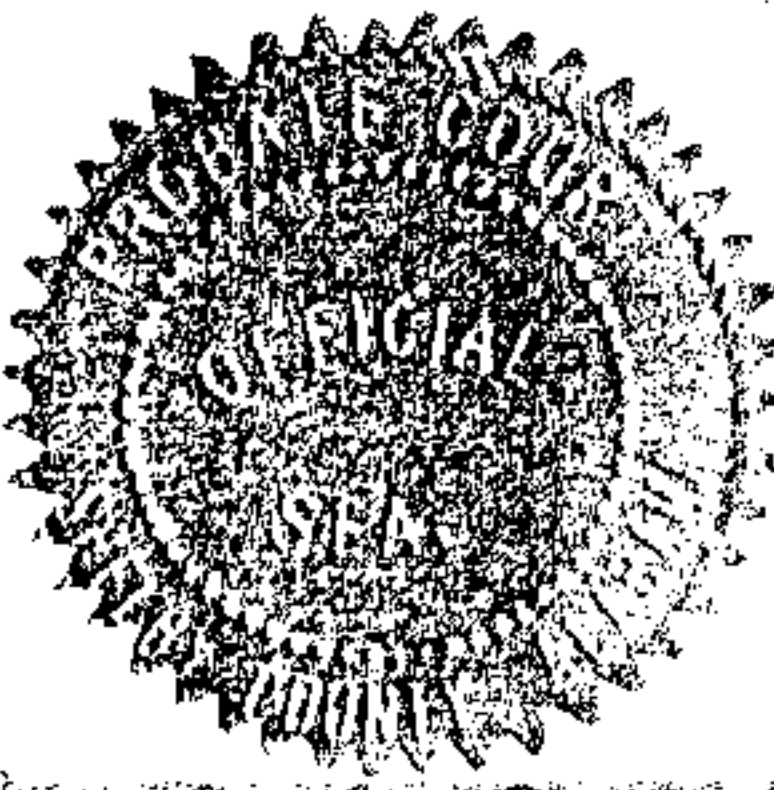
