ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 10-2A-113 of the Code of Alabama, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation heretofore filed in Corporation Book 11, at Page 610, and the Amendment to the Articles of Incorporation of the Corporation dated August 1, 1981 and recorded December 27, 1983, as follows:

FIRST: The name of the corporation is First Real Estate Corporation of Alabama, Inc.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on the 21st day of November, 1983, in the manner prescribed by the Alabama Business Corporation Act.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was Eighty Thousand (80,000); and the number of shares entitled to vote thereon was Eighty Thousand (80,000).

FOURTH: The number of shares voted for such amendment was Eighty Thousand (80,000); and the number of shares voted against such amendment was Zero (0).

FIFTH: The manner in which such amendment effects a change in the amount of stated capital, and the amount of stated capital as changed by such amendment, are as follows: The stated capital is changed by changing the par value of the Eighty Thousand (80,000) shares of the outstanding authorized stock from One and no/100th Dollars (\$1.00) per share to No and 10/100th Dollars (\$0.10) per share, and the amount of stated capital is thereby changed from Eighty Thousand and no/100th Dollars (\$80,000.00) to Eight Thousand and no/100th Dollars (\$8,000.00).
