CORPORATION FORM WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

} KNOW ALL MEN BY THESE PRESENTS,

That in consideration of One hundred thirty thousand and no/100 (\$130,000.00) -----

to the undersigned grantor, Leo James Builders, Inc. a corporation,  
(herein referred to as GRANTOR), in hand paid by the GRANTEEES herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto

Dan Pritchard Wilson and Peggy Calhoun Wilson  
(herein referred to as GRANTEEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to wit:

Lot 86, according to Map of MEADOW BROOK, FIFTH SECTOR - FIRST PHASE, as recorded in Map Book 8, page 109, in the Probate Office of Shelby County, Alabama.

Minerals and mining rights excepted.

Subject to taxes for 1984.

Subject to restrictions, easements, building lines, transmission line permits, agreements with Alabama Power Company and agreement between Daniel International Corp. and Alabama Power Company concerning underground electric services of record.

\$ 80,000.00 of the purchase price recited above was paid from a mortgage loan closed simultaneously herewith.
