Judgment is rendered herein pursuant to stipulation of counsel for plaintiff and defendants, as follows:

It is ORDERED, ADJUDGED, and DECREED:

(1) That judgment be entered herein in favor of SouthTrust Bank of Alabama, National Association, formerly known as Birmingham Trust National Bank, against G & F Homebuilding Company, and George N. Bibb, in the following amounts:

(2) That George N. Bibb pay to SouthTrust Bank of Alabama, National Association, the amount of Twenty-eight Thousand Six Hundred Four and 66/100 Dollars (\$28,604.66);

(3) That G & F Homebuilding Company pay to SouthTrust Bank of Alabama, National Association, the sum of Fourteen Thousand Nine Hundred Thirty-nine and 81/100 Dollars (\$14,939.81);


(4) That SouthTrust Bank of Alabama, National Association, dismiss its claims against Frances D. Bibb based in part upon the ground that as of February 23, 1982, her assets as represented to the Bank were insufficient to pay the amounts claimed against her and also on the ground that she completely denies her liability or obligation to the Bank;

(5) That SouthTrust Bank of Alabama, National Association, release George N. Bibb and Frances D. Bibb from the personal guaranties referred to in plaintiff's complaint and made a part thereof; and


(6) That costs be taxed against plaintiff.


