

QUITCLAIM DEED – Lawyers Title Insurance Corp. – Birmingham, Alabama

KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of the sum of ONE DOLLAR AND NO/100 (\$1.00) AND OTHER GOOD AND VALUABLE CONSIDERATIONS in hand paid to the undersigned, the receipt whereof is hereby acknowledged, the undersigned Eugene Robinson and wife, Elvie Robinson

hereby remises, releases, quit claims, grants, sells, and conveys to

Bertha Adams (as to an undivided one-half interest) and
L. J. Morris and Lilla Morris (as to an undivided one-half interest)
(hereinafter called Grantee), all their right, title, interest and claim in or to the fol-

lowing described real estate, situated in Shelby County, Alabama, to-wit:
Parcel 1 - A part of the SE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 1, Township 21 South, Range 3 West,
described as follows: Beginning 140 yards North of the SE corner of said $\frac{1}{4}$ - $\frac{1}{4}$
Section and run North 148 yards; thence West 100 yards; thence South 148 yards;
thence East 100 yards to point of beginning.
