

QUIT CLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of \$10.00 and other good and valuable consideration in hand paid by the grantee to the undersigned grantor, the receipt of which is hereby acknowledged, the undersigned grantor, SOUTHTRUST BANK OF ALABAMA, NATIONAL ASSOCIATION, (herein referred to as grantor) does hereby remise, release, quit claim and convey to JOHN STEELY and ANNIE M. STEELY (herein referred to as grantees), all its right, title, interest, and claim in or to the following described real estate, situated in Shelby County, Alabama, to-wit:

Part of the SE 1/4 of NE 1/4 of Section 7, Township 20 South, Range 2 West, Shelby County, Alabama, being more particularly described as follows:

From the northwest corner of said 1/4-1/4 section, run in a southerly direction along the West line of said 1/4-1/4 section for a distance of 345.93 feet to the point of beginning; thence turn an angle to the left of 69°18'05" and run in a southeasterly direction for a distance of 351.83 feet; thence turn an angle to the right of 120°11'17" and run in a southwesterly direction for a distance of 32.20 feet to an existing iron pin; thence turn an angle to the right of 61°33'10" and run in a northwesterly direction for a distance of 329.05 feet to an existing iron pin being on the West line of said 1/4-1/4 section; thence turn an angle to the right of 67°33'38" and run in a northerly direction for a distance of 19.07 feet, more or less, to the point of beginning, containing 7,796 square feet, more or less.

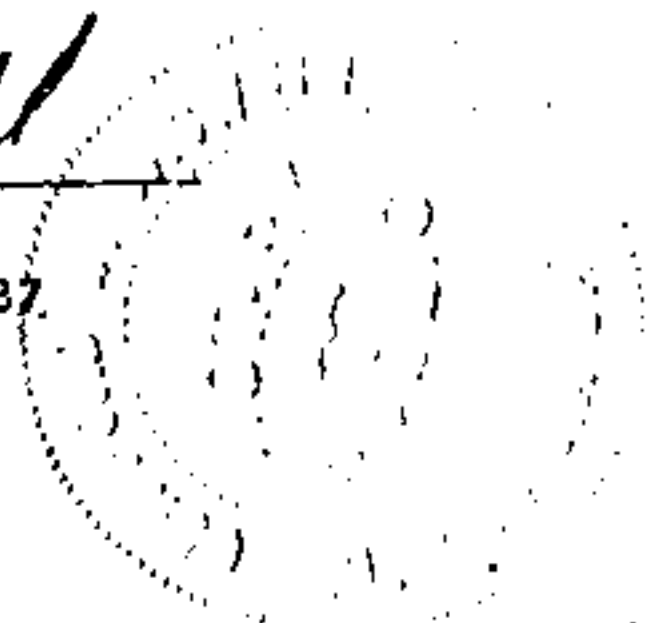
