THE GRANTEE AGREES:

- To cut only the timber specified above.
- To use utmost care in preventing damage to young growth and 2. trees not to be cut. To leave tops, limbs, and other debris away from standing trees.
- To keep any and all roads used for the carrying out of this contract, upon the property of the grantor, in a passable condition.
- To leave all streams free of tops, limbs and other logging debris.
- To prevent damage to fences, powerlines, telephone lines, and other improvements; and to repair such damage if caused by the operations fo the grantee.
- To be especially careful of forest fires and to take precautions to prevent same.
- The grantor shall not be held liable for any claim for damages which may accrue on account of the cutting and removing of said timber and the grantee shall indemnify, protect and save harmless the grantor form all loss, damage, cost, or expense which the grantor may sustain on account of the cutting and removal of said timber from said land and on account of claims by others for damages, whether for personal injury of property damage or otherwise, resulting from or arising out of the cutting and removing of said timber.
