The objects and purposes for which this corporation is formed are:

To operate a glass glazing business, selling and installing all kinds of glass, maintenance of same, selling all glass equipment, articles, products, goods, to buy, sell, lease or otherwise dispose of, and to operate, conduct, furnish, equip, and manage a general business dealing with glass, to perform everything necessary for carrying out the aforesaid purposes:

To buy, sell, acquire, hold and otherwise deal in real estate and land of every class and description.

To improve, manage, develop, sell, assign, transfer, lease, mortgage, pledge or otherwise dispose of or turn to account or deal with all or any part of the property of the corporation, and, from time to time, to vary any investment or employement of the capital of the corporation.

And generally to do and perform the acts and enjoy the powers conferred by the general laws of the State of Alabama as provided by the Alabama Business Corporation Act.
