ARTICLES OF INCORPORATION

(b) To transact any and all lawful business for which corporations may be incorporated under the Laws of Alabama.

(c) To exercise every power incidental to engaging in the siding business and given to corporations generally by the Laws of Alabama.

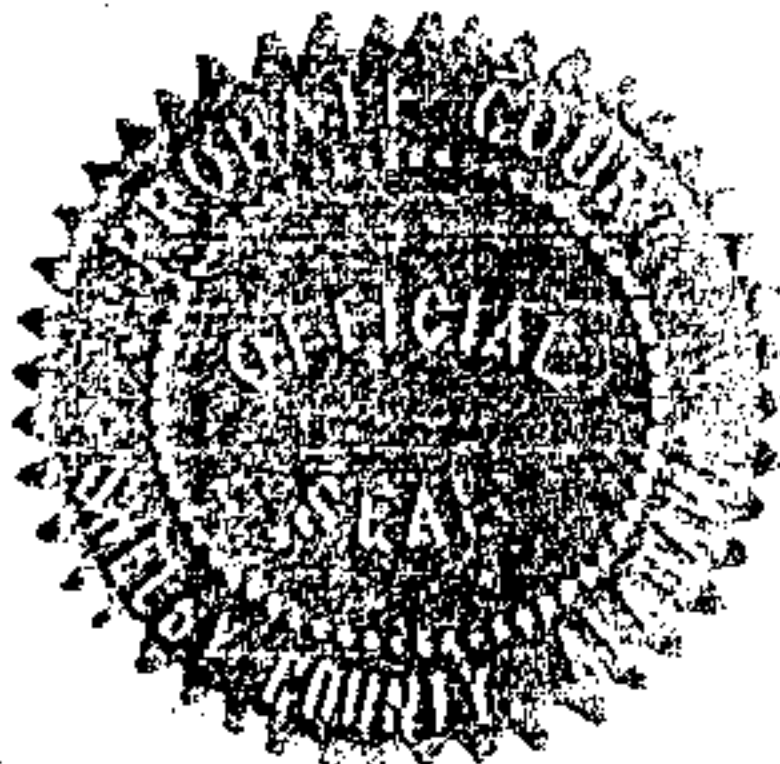
