**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION  
FIRST AMERICAN BANCSHARES, INC.**

Pursuant to the provisions of Section 10-2A-113 of the Code of Alabama, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name and address of the Corporation is First American Bancshares, Inc., 3000 Highway 31 South, Pelham, Alabama 35124.

2. The following amendments to the Articles of Incorporation were adopted by the Board of Directors of the Corporation on January 19, 1984, in the manner prescribed by the Alabama Business Corporation Act.

"FOURTH: Shares of Stock" is amended to read as follows:

"The maximum aggregate number of shares of Common Stock which the corporation shall have authority to issue is One Hundred Thousand (100,000) shares of the par value of Seven and 50/100 Dollars (\$7.50) per share. No shares have preemptive rights.

3. No shares of stock of the Corporation have been issued.

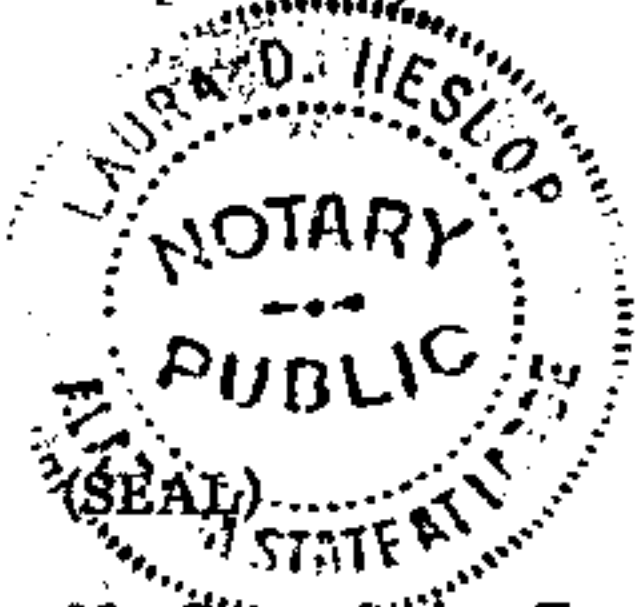

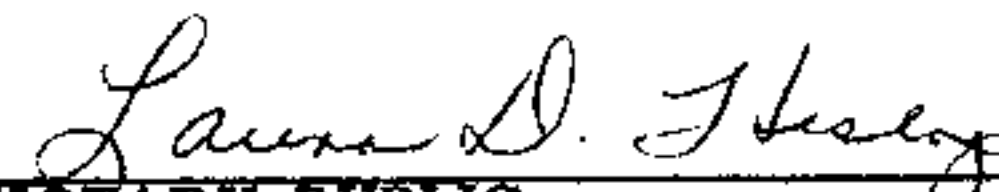
