

## ARTICLES OF INCORPORATION

of the

## MONTEVALLO CHURCH OF THE NAZARENE

We, the undersigned, acting as incorporators of a corporation under the Alabama Nonprofit Corporation Act adopt the following Articles of Incorporation for such Corporation:

ARTICLE I  
NAME

The name of the Corporation shall be:

MONTEVALLO CHURCH OF THE NAZARENE

ARTICLE II  
DURATION

The period of duration is Perpetual.

ARTICLE III  
PURPOSE

The purpose or purposes for which the corporation is organized are:

1. General Purpose: To operate exclusively for religious, charitable or educational purposes, to build up the membership in the local church, to build up the Christian Faith and Holy Character of its members instructing them in the Word of God and in the doctrines of the Church of the Nazarene all being united in prayer for the extension of the Kingdom of Jesus Christ.

2. Ancillary Purposes: The corporation may engage in any lawful purpose or purposes not for pecuniary profit which would cause the denial of the exemption from taxation under the provisions of section 501(a), Internal Revenue Code of 1954, as amended.

ARTICLE IV  
DIRECTORS

There shall be not less than five Directors consisting of the Church Pastor, acting in the capacity as President of the Corporation, the Church Secretary, acting in the capacity as Secretary of the Corporation, and the Board of Trustees as prescribed by the 1980 Manual of the Church of the Nazarene as adopted by the Twentieth General Assembly at

#### ARTICLE VI BY-LAWS

The Corporation hereby adopts the 1980 Manual of the Church of the Nazarene, including duly adopted future amendments thereto as its By-Laws. This Article may be neither amended, rescinded nor revoked.

#### ARTICLE VII DISSOLUTION

Upon the dissolution or disorganization of this Corporation or the Church represented thereby the assets of the Corporation shall be distributed to the District Advisory Board of the Church of the Nazarene. This ARTICLE may be neither amended, rescinded nor revoked.

#### ARTICLE VIII AMENDMENTS

These Articles of Incorporation may be amended but only in such manner as is consistent with its By-Laws.
