KNOW ALL MEN BY THESE PRESENTS:

That in consideration of TWELVE THOUSAND DOLLARS AND no/100

to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we,

ETHELEEN JEANETTE WOOTEN ISBELL and husband, DONALD ISBELL

(herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto

WANDA KAY WOOTEN KENT, GARY LANE WOOTEN, JERRY LYNN WOOTEN, DONNA MARIE ELLISON, AND PAMELA SUE DUNAWAY.

(herein referred to as grantee, whether one or more), the following described real estate, situated in

SHELBY County, Alabama, to-wit:

From the Northwest corner of the E $\frac{1}{2}$ of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 14, Township 19 South, Range 2 West, run Southerly along the West boundary line of the said E $\frac{1}{2}$ of SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 14, Township 19 South, Range 2 West for 229.97 feet to the point of beginning of the land herein described; thence continue Southerly along the West boundary line of the E $\frac{1}{2}$ of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 14, Township 19 South, Range 2 West 790.0 feet, more or less, to a point on the center line of a County Road; thence turn an angle of 49 deg. 31 min. to the left and run Southeasterly along the center line of said road for 98.36 feet; thence turn an angle of 10 deg. 15 min. to the left and continue Southeasterly along the center line of said road 166.75 feet; thence turn an angle of 120 deg. 14 min. to the left and run Northerly for 931.74 feet; thence turn an angle of 88 deg. 24 min. 35 sec. to the left and run Westerly 218.97 feet, more or less, to the point of beginning.

EXCEPTED however, from the above described land the right of way of the County Road as now located. Also reserved for the purpose of a roadway a strip of land on the West side of the above described land being 15 feet in width.

This land being a part of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 14, Township 19 South, Range 2 West, Shelby County, Alabama.
