A parcel of land situated in the northeast quarter of Section 14, Township 19 South, Range 2 West, Shelby County, Alabama, being more particularly described as follows:

Begin at a 3" capped iron found at the northeast corner of said Section 14; thence run in a southerly direction along the east line thereof for a measured distance of 1998.47 feet (1999.54 feet recorded) to a 3/4" rebar set; thence turn an angle to the right of 92°-01'-23" (92°-01'-30" recorded) and run in a westerly direction for a measured distance of 1299.39 feet (1300.00 feet recorded) to an iron pin found; thence turn an angle to the left of 92°-02'-52" (92°-01'-30" recorded) and run in a southerly direction for a distance of 482.88 feet to an iron pin found at an angle point in the easterly line of Lot 4, Block 6, as shown on a map entitled "Sunny Meadows Phase 2", dated July 26, 1979, prepared by Allen Whitley, Land Surveyor, and recorded in the Office of the Judge of Probate, Shelby County, Alabama, in Map Book 8 on Page 19 A&B; thence turn an angle to the right of 136°-39'-50" (136°-40'-00" recorded) and run in a northwesterly direction along the northeasterly line of said lot and continuing on a projection thereof across a 60.00 foot right-of-way for "Sunny Meadows Court" and along the northeasterly or rear lines of Lots 1, 2, 3, 4 and 5 of Block 8 of said "Sunny Meadows Phase 2" for a measured distance of 769.20 feet (769.15 feet recorded) to an iron pin found at the northernmost corner of said Lot 5; thence turn an angle to the left of 90°-00'-00" and run in a southwesterly direction along the northwest line of said lot for a distance of 160.00 feet to an iron pin set in the easterly right-of-way line of "Sunny Meadows Drive"; thence turn an angle to the right of 90°-00'-00" and run in a northwesterly direction along said right-of-way line for a distance of 174.82 feet to an iron pin set at the northwesterly limit thereof, thence turn an angle to the right of 43°-48'-58" and leaving said right-of-way line, run in a northerly direction for a distance of 1922.38 feet to an iron pin found in the north line of the aforesaid Section 14; thence turn an angle to the right of 91°-18'-58" and run in an easterly direction along said north line for a distance of 2048.55 feet to the point of beginning. Containing 96.649 acres, more or less.
