That in consideration of One Hundred and no/100----- DOLLARS
and other good and valuable consideration

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,

Edward L. Lansford and wife, Nina Lansford

(herein referred to as grantors) do grant, bargain, sell and convey unto

Harold Argo and Priscilla Argo

(herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in _____

Shelby County, Alabama to-wit:

A parcel of land containing 4.57 acres, more or less, located in the NE $\frac{1}{4}$ of Section 10, Township 19 South, Range 2 East, described as follows: Commence at the NE corner of said Section 10; thence run South along the East Section line a distance of 1302.33 feet; thence turn right 90 deg. 00 min. 00 sec. a distance of 1748.60 feet to a point on the Southerly right-of-way of Highway #464 and the point of beginning; thence turn left 03 deg. 05 min. 38 sec. along said right-of-way a distance of 370.72 feet; thence turn left 110 deg. 28 min. 56 sec. a distance of 721.40 feet; thence turn left 93 deg. 10 min. 56 sec. a distance of 257.64 feet; thence turn left 77 deg. 57 min. 15 sec. a distance of 584.36 feet to the point of beginning.

And I (we) do for myself (ourselves) and for my (our) heirs executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.
