Commence at the Northeast corner of Section 34, Township 21 South, Range 1 West, thence run West along the North line of said Section 34, a distance of 830.01 feet to the point of beginning; thence turn an angle of 87 deg. 48 min. 30 sec. to the left and run a distance of 118.75 feet; thence turn an angle of 91 deg. 44 min. 54 sec. to the right and run a distance of 258.26 feet; thence turn an angle of 82 deg. 26 min. 24 sec. to the left and run a distance of 102.70 feet; thence turn an angle of 82 deg. 12 min. 09 sec. to the right and run a distance of 225.65 feet to the East right of way line of Alabama State Highway No. 25; thence turn an angle of 127 deg. 30 min. 23 sec. to the right and run along said Highway right of way a distance of 248.55 feet; thence turn an angle of 0 deg. 53 min. 15 sec. to the right and continue along said Highway right of way a distance of 168.95 feet; thence turn an angle of 55 deg. 35 min. 38 sec. to the right and run a distance of 236.55 feet; thence turn an angle of 84 deg. 30 min. to the right and run a distance of 93.77 feet to the point of beginning; being situated in the NE 1/4 of the NE 1/4 of Section 34 and the SE 1/4 of the SE 1/4 of Section 27, all in Township 21 South, Range 1 West, Shelby County, Alabama.
