ARTICLES OF INCORPORATION

AAA MOBILE HOME MOVERS, INC.

The undersigned, acting as incorporators of a corporation under the Alabama Business Corporation Act (Code of Alabama 1975, Sec. 10-2A-1, et seq.), adopt the following Articles of Incorporation for such corporation:

I.

The name of the corporation is AAA Mobile Home Movers, Inc.

II.

The period of the duration of the corporation shall be perpetual.

III.

The purpose or purposes for which the corporation is organized are:

- 1. To buy, sell, lease, mortgage and otherwise encumber or deal in new or used motor vehicles, earth moving equipment, shop and repair tools, office equipment, furniture and supplies, construction equipment, material and supplies of all types.

 - 2. To engage in the purchase, sale, mortgage, lease, rental and development of real property as purchaser, mortgagor, leasee, seller, mortgagee or lessor, or otherwise.
 - 3. To invest money in all kinds of property, both real, personal and mixed, and to own and maintain all types of real property, real, personal and mixed, including bank accounts of all typed in the corporate name.
 - 4. To buy, sell, own and deal in securities of all kinds.
 - 5. To borrow and lend money, with or without security, and to mortgage, pledge, or hypothecate any property the corporation may own, regardless of its nature or the evidence of the same.
 - 6. To negotiate loans and discounts, to buy and sell stocks, bonds and other securities as agents for its own account or otherwise.
 - 7. To develop, acquire, sell, lease, mortgage, pledge, or hypothecate real or personal and mixed property of all kinds and to build houses, buildings and structures, to own tractors and trailers, and vehicular equipment, to promote, organize and control land compaines, town-site companies, construction companies, industrial companies,

transportation companies, mercantile or other commercial companies, or any company having the power to carry on any of the businesses hereinbefore set forth or referred to, or having power to exercise any or all of the powers which this company may exercise, and to become an incorporator of any company or to cause its incorporation, and to subscribe for and own, hold, dispose of the capital stock of any such company or securities of any such company to any extent.

- 8. To improve, manage, develop, sell, assign, transfer, lease, mortgage, pledge or otherwise dispose of or turn to account or deal with all or any part of the property, real or personal, of the corporation and, from time to time, to vary any investment or employment of the capital of the corporation.
- To borrow money, and to make and issue notes, bonds, debentures, mortgages and evidences of indebtedness of all kinds, whether secured by mortgage, pledge or otherwise, without limit as to amount, and to secure the same by mortgage, pledge or otherwise; and generally to make and
- perform agreements and contracts of every kind and description.

 10. To the same extent as natural persons might or could do, to purchase or otherwise acquire, and to hold, own, maintain, work, develop, and to hold, own, and deal in, lands and leaseholds, any interest, estate and rights in real property, and any personal mixed property, and any franchises, rights, licenses or privileges necessary, convenient or appropriate for any of the purposes herein expressed.
 - 11. To buy and sell goods, wares, and merchandise of every class and description which can be lawfully sold.
 - To engage in the business of building and excavation, construction, destruction and repair, highway, railroad, bridge and all other types of construction, destruction, repair, and incidentally transportation of materials and supplies related to the formage and activity, and all other business functions necessary or incidental to the conduct of these businesses, and to effect the objects and purposes for which this corporation was formed.
 - 13. And, generally, to transact any and all lawful business for which corporations may be incorporated under the Alabam Business Corporation Act, doing and performing all of the acts and enjoying all the powers conferred by the general laws of the State of Alabam as stated therein, and as amended.

IV.

The aggregate number of shares which the corporation shall have authority to issue shall be 100 shares with a par value of \$10.00 per each share.

Provisions for the regulation of the internal affairs of the corporation are:

- 1. Transfer of shares is restricted, as noted conspicuously on such shares, with the restriction obligating any holder of such share to offer to the corporation are (first), or thereafter to any other holder of shares, (secondly), a prior opportunity for purchase or acquisition to be exercised within a reasonable time.
- 2. Other provisions for the regulation of the internal affairs of the corporation are to be set forth in the By-laws of the corporation.

VI.

The address of the initial registered office of the corporation shall be at 32 Monte Tierra Trail, Montevallo, Al. 35115. The name of the initial registered agent for the corporation at such address shall be Bobby J. Bush.

VII.
