That in consideration of SIXTY-TWO THOUSAND FIVE HUNDRED AND NO/100 (\$62,500.00) DOLLARS

to the undersigned grantor, STRAIN CONSTRUCTION, INC. a corporation,
(herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the
said GRANTOR does by these presents, grant, bargain, sell and convey unto

FRED E. PRINGLE, JR. and wife, DEBORAH H. PRINGLE

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor
of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate,
situated in the County of Shelby, State of Alabama, to-wit:

Lot 2, Block 4, according to the Survey of the Amended Map of
Plantation South, First Sector, as recorded in Map Book 7, Page
173, in the Probate Office of Shelby County, Alabama.
