KNOW ALL MEN BY THESE PRESENTS, that in consideration of SEVENTY NINE THOUSAND EIGHT HUNDRED DOLLARS & 00/100 (\$79,800.00) to the undersigned grantor, AWTREY BUILDING CORPORATION, INC. a corporation, (hereinafter referred to as GRANTOR does by these presents, grant, bargain, sell and convey unto BARRY CAMPBELL and TAMMY CARTER CAMPBELL, husband and wife (herein referred to as GRANTEEES) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to wit:

Lot 320, according to the Survey of Chandalar South, Sixth Sector Addition as recorded in Map Book 7, Page 50, in the Probate Office of Shelby County, Alabama.

Except a parcel of land 3' wide 175' long being the most southwesterly part of Lot 320.

Subject to easements, restrictions and rights of way of record.
