

ARTICLES OF AMENDMENT
TO THE

Pursuant to the provisions of Section 69 of the Alabama Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is
Inverness Elementary Parent-Teacher Organization.

SECOND: The following Amendments of the Articles of Incorporation were adopted by the Board of Directors of the Corporation on April 16, 1984, in the manner prescribed by the Alabama Business Corporation Act:

"The purposes for which the Corporation is organized are exclusively charitable and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law."

THIRD: The above Amendment completely supercedes the Third Article of Incorporation filed originally on January 10, 1984.
