I further authorize the assignee, Central State Bank, to collect on my behalf any and all funds due or to become due pursuant to the terms of the above contract agreement.

I shall have no authority, without assignee's prior written consent, to accept any checks, drafts, or payments to be issued pursuant to said contract agreement between myself and the Alabama Power Company or to modify, change, or enlarge the terms of the contract agreement above assigned.

Any and all moneys or payments that may be received by me to which the assignee, Central State Bank, is entitled by reason of this assignment shall be received by me as trustee for the assignee, and will be immediately delivered to the assignee without commingling with any of my other funds. I warrant to the assignee that the monies above assigned have not heretofore been alienated or assigned.

This assignment is complete and irrevocable, and shall remain in full force and effect until a release in writing thereof is given to me by the assignee, Central State Bank.
