

ARTICLES OF INCORPORATION OF

We, the undersigned, being three natural persons of the age of 19 years or more, acting as incorporators of a corporation under the Alabama Non-Profit Corporation Act, §§10-3-1 to 10-3-172 of the 1975 Alabama Code, as amended, hereby sign, verify, and file the following articles of incorporation:

- (1) The name of the corporation is: Tabernacles of Deliverance, Inc.
- (2) The period of duration of the corporation is perpetual.
- (3) The purposes for which the corporation is organized shall be charitable, benevolent, eleemosynary, educational, civic, and religious.
- (4) The corporation shall have one class of members.
- (5) The directors shall be elected by the members.
- (6) The internal affairs of the corporation shall be regulated by the bylaws, consistently with applicable law and these articles.







(11) Notwithstanding any of the powers or purposes of the corporation contained in this certificate of incorporation or granted by law, this corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, nor shall it engage in any activity of any kind whatever involving the carrying on of propaganda, nor shall it attempt in any manner to influence legislation, nor shall it engage in any activities which are not in themselves tax-exempt under the Internal Revenue Code of the United States of America. If the corporation is ever dissolved, its assets shall be distributed only to the government of the United States of America, the state of Alabama, or the the city of Montevallo, and moreover, said assets may only be used for a public purpose.

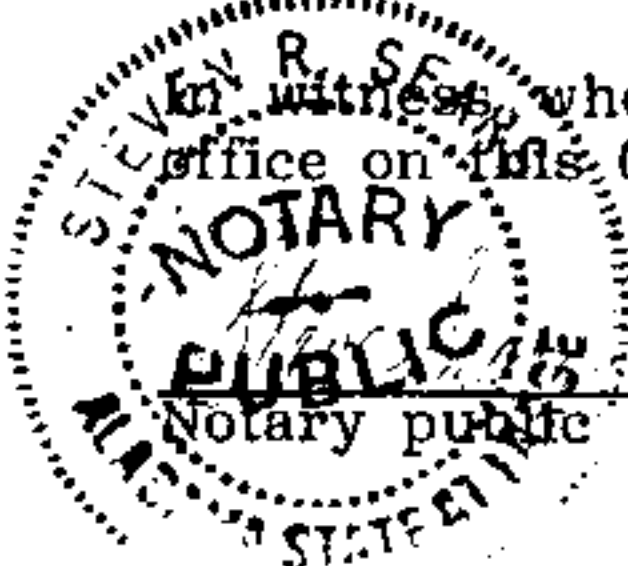
