Know all men by these presents, that in consideration of one thousand dollars and other good and valuable consideration, to the undersigned grantor in hand paid by the grantee herein, the receipt whereof is acknowledged, I, Ralph W. Sears, and wife Marcia M. Sears, of BX 444, Montevallo, AL 35115 (herein referred to as grantor, whether one or more) do grant, bargain, sell, and convey unto Shelby County Newspapers, Inc., of BX 947, Columbiana, AL 35051 (herein referred to as grantee, whether one or more) the following described real estate situated in Shelby County, Alabama, to-wit:

Begin at the NE corner of §26, Twp 21S, R1W, thence run S along § line 264 feet to a point at back of sidewalk on N side of E College Street being the front corner between the W. S. Lokey and Frank Norris Lots; thence S 61°30'W, 269 feet to a point; thence S 86°30'W, 224.15 feet to a point on the W line of Main Street and three (3) feet S of the N line of W College Street, 143.50 feet to the E line of Imperial Spreads building; thence 80.7 feet N along Imperial Spreads E building line to the S face of Shelby County Reporter building's S wall, said wall being a party wall, for the point of beginning; thence W 83 feet to the E side of a 10-foot alley; thence N 28 feet along the E side of said alley, thence E along the face of the Reporter building's N wall which is a party wall with the Gordon & White building, 83 feet; thence S 28 feet to the point of beginning, situated in Shelby County, Alabama.

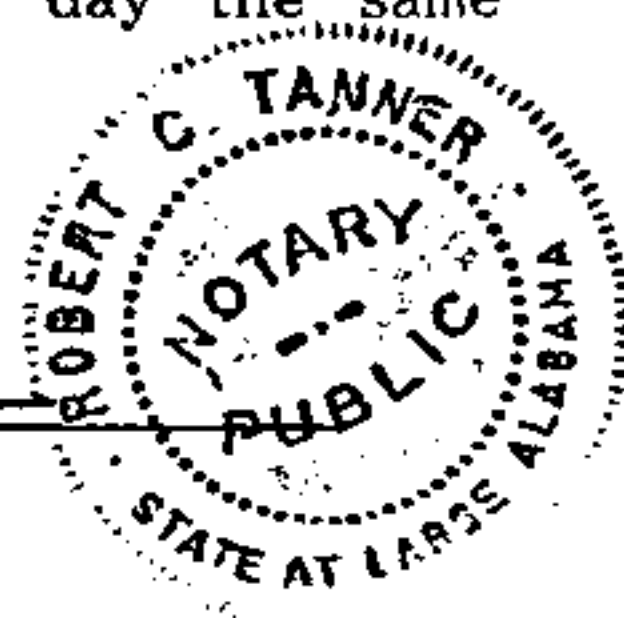
