ARTICLES OF INCORPORATION  
OF

CALERA PARENTS AND CHILDREN CLUB, INC.

The undersigned, acting as incorporators of a nonprofit corporation under the Code of Alabama, hereby adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Calera Parents and Children Club, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are:

(a) to provide organization and support for Calera Youth Football;

(b) to support and raise funds to cover expenses for equipment, uniforms, league fees, referees, lights and playing location for the Calera Youth Football;

(c) to have and exercise all powers provided by the "Alabama Nonprofit Corporation Act";

(d) to have and exercise all powers necessary or convenient to effect any, or all of the purposes for which the corporation is organized.

FOURTH: This corporation is a nonprofit corporation dedicated to the support of Calera Youth Football;

FIFTH: All persons who desire to assist in promoting the purposes of this corporation and are found otherwise qualified by the Board of Directors may become members of this corporation in the manner from time to time provided by its bylaws.

SIXTH: The board of directors shall be elected or appointed as provided by the bylaws and the affairs of the corporation shall be managed by the board of directors.



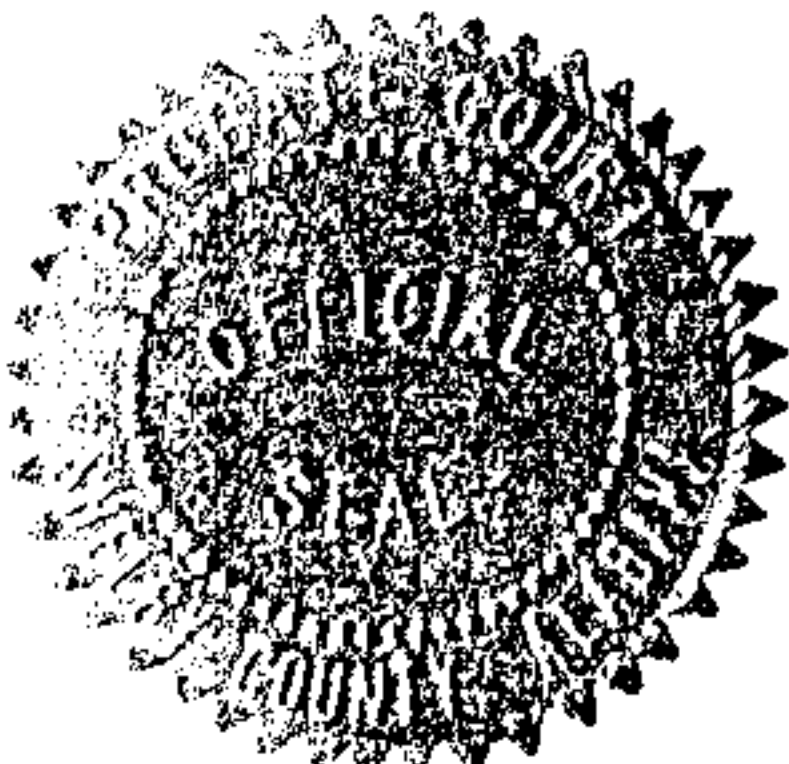
