DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, which are intended to constitute a Durable Power of Attorney, that I, Willa Mae Panter Whatley, the undersigned, of 1144 Iredell Circle, City of Homewood, County of Jefferson, State of Alabama, do hereby make, constitute and appoint William H. Panter of 2700 Altadena Lake Road, City of Birmingham, County of Jefferson, State of Alabama, my true and lawful Attorney in Fact, for me and in my name, place and stead, and on my behalf and for my use and benefit, to do and execute all or any of the following acts, deeds, and things, as fully as if I might or could do if personally present, to-wit:

To execute contracts for the sale or exchange of real and personal property; to execute deeds, affidavits, lien waivers and other necessary documents relating to the conveyance of real property; to execute closing statements and other documents relating to the sale of real property; and to receive, acknowledge and accept notes, mortgages, checks, cash or other instruments as may be necessary or proper relating to the payment of the consideration for the sale of such real property. The rights and powers conferred herein shall be limited and relate only to the real and personal property interests that I have in such property situated in Chilton and Shelby Counties, in the State of Alabama.

I grant to my said Attorney in Fact full power and authority to do, take and perform all and every act and thing whatsoever requisite, proper, or necessary to be done, in the exercise of any of the rights and powers herein granted, as fully to all intents and purposes as I might or could do if personally present, with full power of substitution or revocation, hereby ratifying and confirming all that my said Attorney in Fact, or his substitute, shall lawfully do or cause to be done by virtue

of this power of attorney and the rights and powers herein granted.

This instrument is to be construed and interpreted as a durable and general power of attorney. The enumeration of specific items, rights, acts or powers herein is not intended to, nor does it, limit or restrict, and is not to be construed or interpreted as limiting or restricting, the general powers herein granted to my said Attorney in Fact.

IN WITNESS WHEREOF, as Principal, I have signed this Durable Power of Attorney at Birmingham, Alabama, this 19th day of May, 1984, and I have directed that photographic copies of this power be made which shall have the same force and effect as an original.
