WHEREAS, on the 13th day of April 19 81, a decree was rendered by the Probate Court of said County for the sale of the lands hereinafter described and conveyed for the State and County taxes then due from Guy L. Chamberlin

AND WHEREAS, thereafter, to-wit, on the 20th day of May 19 81, said lands were duly and regularly sold by the Tax Collector of said county for taxes, costs and expenses,
