KNOW ALL MEN BY THESE PRESENTS that, for and in consideration of One Hundred Dollars (\$100.00) and other valuable considerations paid to UNITED STATES STEEL CORPORATION, a Delaware corporation, hereinafter called "Grantor", by KENNETH O. FARRIS and wife, CLAUDIA S. FARRIS, hereinafter called "Grantees", receipt of which is acknowledged, the said Grantor does hereby grant, bargain, sell and convey unto the said Grantees, for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to wit:

Lot 5, according to the survey of
Heatherwood, 1st Sector, as recorded in Map
Book 8, Page 27 A & B in the office of the
Judge of Probate of Shelby County, Alabama.

TO HAVE AND TO HOLD unto the said Grantees for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor forever together with every contingent remainder and right of reversion; SUBJECT, however, to the following: (a) such easements not specifically referred to herein as may exist over, upon or across said land for public roads, electric power transmission lines, telephone lines, telegraph lines or pipelines; (b) applicable zoning and subdivision regulations; (c) taxes for the current tax year; (d) restrictions, covenants and conditions as set out in instrument recorded in Misc. Book 37 Page 537 in said Probate Office; (e) agreement with Alabama Power Company as to underground cables recorded in Misc. Book 39 Page 981 and covenants pertaining thereto recorded in Misc. Book 39 Page 980 in said Probate Office; (f) right of way to South Central Bell as shown by Deed Book 282, Page 115 in said Probate Office; (g) easement to Alabama Power Company as shown by Deed Book 318, Page 16 in said Probate Office; and (h) public utility easements as shown by recorded plat, including 5 foot easement on North and South sides and an irregular easement on the East side.

And the Grantor does for itself and for its successors and assigns covenant with the Grantees, Grantees' heirs and assigns, that it is lawfully seized in fee simple of the lands conveyed hereby; that they are free from all encumbrances, except as herein mentioned; that it has a good right to sell and convey the same as aforesaid; and that it will and its successors and assigns shall warrant and defend the same to the Grantees, Grantees' heirs and assigns, forever against the lawful claims of all persons.

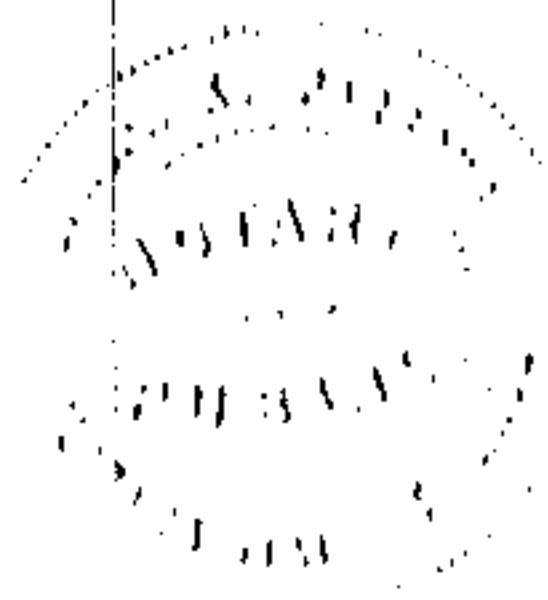
