ITEM I

Identity of Testatrix' Family

I hereby declare that I am married to WILSON BURKE JOHNSON and all references in this Will to "my husband" are references to him.

I have two (2) adult children, namely ALMA BERNICE JACKSON and WILLIAM MICHAEL SMITH, presently living, who were born to me of a previous marriage, and all references in this Will to "my children" are references to them.

ITEM II

Disposition of Property

It is my intention by this Will to dispose of all real, personal, and mixed property which I may own which is subject to the control of this Will. With this objective in mind, I hereby grant unto my husband, WILSON BURKE JOHNSON, a life estate in all of my said property, and at his death, I give, devise and bequeath all of my property in fee to my children, ALMA BERNICE JACKSON and WILLIAM MICHAEL SMITH, and to DOUGLAS WAYNE JOHNSON and BRENDA ANN BOYKIN, who are my husband's children by a previous marriage. Except, I wish to give, devise and bequeath any and all property that I may receive from any of my relatives by Will or inheritance to go directly to my two (2) children, ALMA BERNICE JACKSON and WILLIAM MICHAEL SMITH, at the time of my death.

Attestation Clause

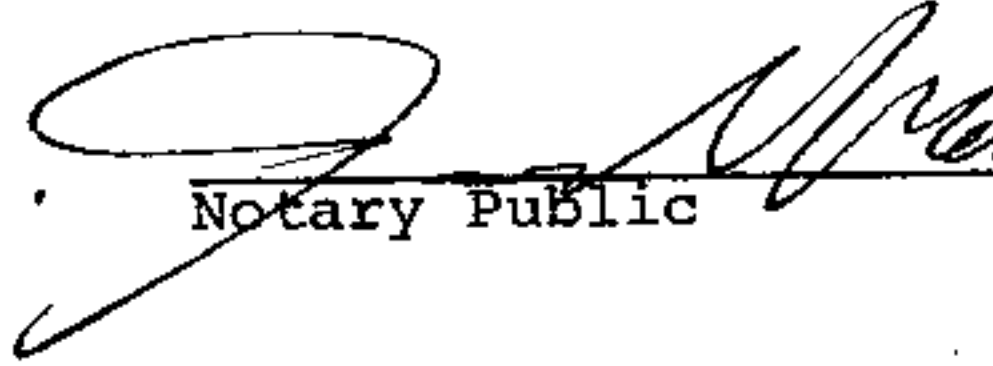

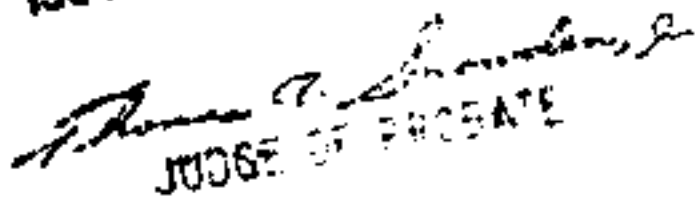
