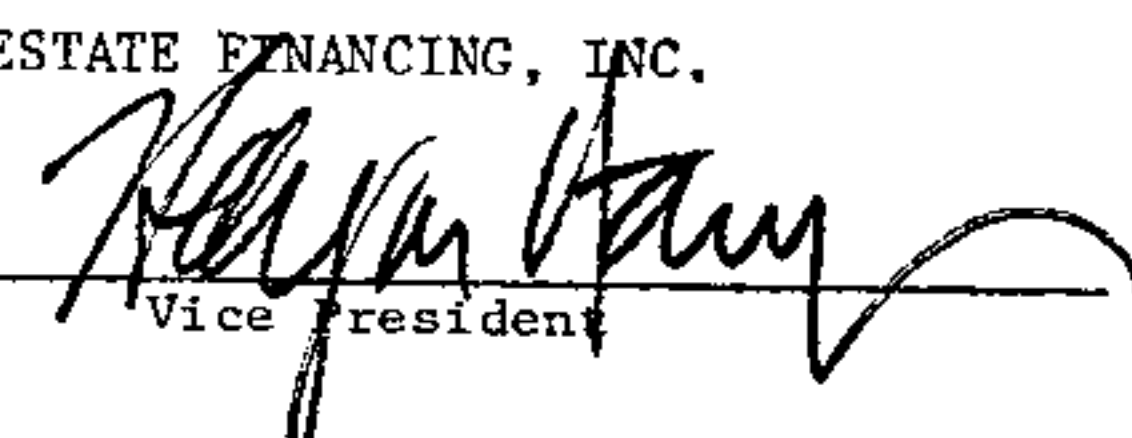

TO HAVE AND TO HOLD unto the said First Alabama Bank of Birmingham, N.A. its successors and assigns, FOREVER.

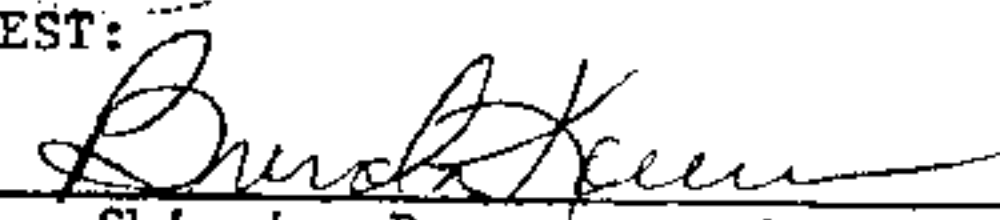

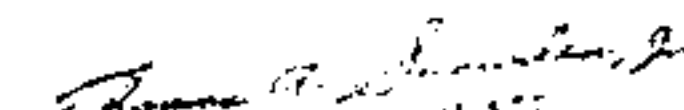
