That in consideration of One Hundred Twelve Thousand and No/100 ----- DOLLARS

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,

(herein referred to as grantors) do grant, bargain, sell and convey unto

Paul D. Wingate and Debra S. Wingate

(herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate situated in

SHELBY

County, Alabama to-wit:

Lot 12, according to the Survey of Indian Valley Lake Estates, First Sector, as recorded in Map Book 5, Page 130, in the Probate Office of Shelby County, Alabama. Mineral and mining rights excepted.

SUBJECT TO:

1. Thirty-five foot building line as shown by recorded plat.
2. Ten foot easement along west side and south side of subject property as shown by recorded plat for public utilities, sanitary sewers, storm sewers, storm ditches.
3. Right of Way to Alabama Power Company and Southern Bell Telephone & Telegraph Company as recorded in Volume 282, Page 307, in the said Probate Office.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.
