KNOW ALL MEN BY THESE PRESENTS: That I, Rudolf Schmarsow, of the Town of Wiesbaden, District of Auringen, West Germany, have made, constituted and appointed, and by these presents do make, constitute and appoint Jeanette Krumdieck, my true and lawful attorney for me and in my name, place and stead, and for my use and benefit, to ask, demand, sue for, recover, collect and receive all such sums of money, insurance claims, debts, dues accounts, legacies, bequests, interests, dividends, annuities and demands whatsoever as are now, or shall hereafter become due, owing, payable or belonging to me, and have, use and take all lawful ways and means in my name or otherwise for the recovery thereof, by attachments, arrests, distress or otherwise, and to compromise and agree for the same, for me, and in my name, to make, seal, and deliver; to bargain, contract, agree for, purchase, receive, and take lands, tenements, hereditaments and accept the seizing and possession of all lands and all deeds and other assurances, in the law therefor, and to lease, let, demise, bargain, sell, remise, release, convey, mortgage, and hypothecate lands, tenements, and hereditaments, upon such terms and conditions, and under such covenants, as she shall think fit.

Also to bargain and agree for, buy, sell, mortgage, hypothecate and in any and every way and manner deal in and with goods, wares, and merchandise, choses in action and other property in possession or in action, and to make, do, transact all and every kind of business of whatsoever nature or kind, and also for me and in my name, and as my act and deed, to sign, seal, execute, deliver and acknowledge such deeds, leases and assignments of leases, covenants, indentures, agreements, mortgages, bills of lading, bills, bonds, notes, receipts, evidence of debts,

releases and satisfaction of mortgage, judgments and other debts, and such other instruments in writing of whatever kind and nature as may be necessary or proper in the premises.

Also to receive all policies of insurance, stock certificates, bonds, deeds and any and all other kinds of evidences of indebtedness which may exist between myself and any other person, firm or corporation whatsoever and I do hereby authorize the said Jeanette Krumdieck to receive in my name any and all kinds of information, documents, instruments or letters to which I may be entitled.

My attorney is hereby authorized legally to sell, buy, mortgage, exchange, and in any manner legally to dispose of any and all property, real, personal and mixed, belonging to the undersigned, wherever located.

And I, the said Rudolf Schmarsow, do hereby ratify and confirm all whatsoever my said attorney, or her substitute, or substitutes, has done, shall do, or cause to be done, on or about the premises, by virtue of this Power of Attorney.

Giving and granting unto my said attorney full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done in and about the premises, as fully to all intents and purposes as I might or could do if personally present, with full power of substitution or revocation, hereby ratifying and confirming all that my said attorney, or her substitute or substitutes shall lawfully do or cause to be done by virtue of these presents.


