KNOW ALL MEN BY THESE PRESENTS: That I, Rosemarie Schmarsow,

have made, constituted and appointed, and by these presents do
make, constitute and appoint Jeanette Krumdieck, my true and law-
ful attorney for me and in my name, place and stead, and for my

and to compromise and agree for the same, for me, and in my
name, to make, seal, and deliver; to bargain, contract, agree
for, purchase, receive, and take lands, tenements, hereditaments
and accept the seizing and possession of all lands and all deeds
and other assurances, in the law therefor, and to lease, let,
demise, bargain, sell, remise, release, convey, mortgage, and
hypothecate lands, tenements, and hereditaments, upon such terms
and conditions, and under such covenants, as she shall think fit.

Also to bargain and agree for, buy, sell, mortgage, hypoth-
ecate and in any and every way and manner deal in and with goods,
wares, and merchandise, choses in action and other property in
possession or in action, and to make, do, transact all and every
kind of business of whatsoever nature or kind, and also for me
and in my name, and as my act and deed, to sign, seal, execute,
deliver and acknowledge such deeds, leases and assignments of
leases, covenants, indentures, agreements, mortgages, bills of
lading, bills, bonds, notes, receipts, evidence of debts,

releases and satisfaction of mortgage, judgments and other debts, and such other instruments in writing of whatever kind and nature as may be necessary or proper in the premises.

Also to receive all policies of insurance, stock certificates, bonds, deeds and any and all other kinds of evidences of indebtedness which may exist between myself and any other person, firm or corporation whatsoever and I do hereby authorize the said Jeanette Krumdieck to receive in my name any and all kinds of information, documents, instruments or letters to which I may be entitled.

My attorney is hereby authorized legally to sell, buy, mortgage, exchange, and in any manner legally to dispose of any and all property, real, personal and mixed, belonging to the undersigned, wherever located.
