AMENDED FINAL DECREE NUNC PRO TUNC	

The Amended Final Decree of February 29, 1984, is hereby AMENDED to read upon per the petition of Nunc Pro Tunc for the heirs of James Laxton Finley, Jr. The Court is of the opinion that Paragraph Nineteen of the Amended Final Decree contains some language that needs to be corrected in reference to the heirs of Hattie Finley Bailey and second, that one of the heirs of Albert Prince Finley was deceased prior to the date of the Amended Final Decree of February 29, 1984.

04 It is hereby ORDERED, ADJUDGED and DECREED that the Final Amended Decree of February 29, 1984, is hereby amended as follows:

BOOK 003 PAGE 04
A. Paragraph Nineteen of the Final Amended Decree shall read as follows: Hattie Finley Bailey died intestate in the year of 1965 having had nine (9) children. Five of the children survived their mother, Hattie Finley Bailey, and they are as follows; J. D. Bailey, James William Bailey, Leon Bailey, Willie Bailey and Geneva Bailey. Lena Bailey, T. S. Bailey and Y. L. Bailey predeceased their mother and died intestate and without issue. Ruth Bailey predeceased her mother and died intestate leaving two surviving children, Joann Bailey and Albert Bailey.

B. Paragraph Eighteen should be amended to show that James Lawton Finley, Sr. died intestate on February 21, 1983 and was survived by a widow, Gertrude Finley and ten children, nine of said children being born by he and the widow, Gertrude Finley, and the other one child, Rosa Finley, by a prior marriage. The nine children are as follows: James Laxton Finley, Jr., 3520 2nd Ave. No., Dolomite, Alabama 35061; Shirley Ann Henderson, 1735 Davidson, #3F, Bronx, New York 10453; Loretta F. Nation, 750 7th Street W., Graysville, Alabama 35073; Lorena F. Brown, 1217 Highlan Drive, Fairfield, Alabama 35064; Vaness Finley Willis, 842 McMillan Ave., Birmingham, Alabama 35211; Alex Clarence Finley, Rt. 1, Box 239, #10, Spring City, Tennessee 37381; Carolyn Finley, 2912-F S.J. Bennett Dr., Birmingham, Alabama 35073; Veronica F. Griffin, Rt. 1, Box 640, Graysville, Alabama 35073; Nathaniel Finley, 1036 6th Street W., Birmingham, Alabama

35204. The tenth child, Rosa Finley is by a previous marriage and her address is 930 S. Walufield Street, Apt. 141, Arlington, Virginia 22204.

It is therefore, ORDERED, ADJUDGED and DECREED that the said Amended Final Decree of February 29, 1984, shall be amended to delete from Paragraph Three the name of James Lawton Finley, Sr. and his interest of 1/36 shall be divided as follows: Gertrude Finley and 1/72 to James Laxton Finley, Jr., Shirley Ann Henderson, Loretta F. Nation, Lorena F. Brown, Vanessa Finley Willis, Alex Clarence Finley, Carolyn Finley, Veronica F. Griffin and Nathaniel Finley, and 1/720 to Rosa Finley.

AND FURTHER, Paragraph Six of the Amended Final Decree shall delete the name of James Lawton Finley, Sr. and his percentage of inheritance of 2.778 is hereby deleted and his percentage is hereby divided as follows:

Gertrude Finley - 1.3889
James Laxton Finley, Jr. - .13889
Shirley Ann Henderson - .13889
Loretta F. Nation - .13889
Lorena F. Brown - .13889
Vanessa Finley Willis - .13889
Alex Clarence Finley - .13889
Carolyn Finley - .13889
Veronica F. Griffin - .13889
Nathaniel Finley - .13889
Rosa Finley - .13889

All of the remaining part of the Amended Final Decree of February 29, 1984 shall remain the same as unchanged.
