An easement 20' in width lying 10' either side of the center line of the Sanitary Sewer as shown on Sheet 2 of the plans of Alabaster, "Sanitary Sewer Additions," September 1983, or as constructed. Said easement being situated in the NWz of Section 1, Township 21 South, Range 3 West, Shelby County, Alabama, and more particularly in the western 2 of Parcel 27, Ownership Map Block 3 as shown in Shelby County Tax Map No. 58-23-01-01-2.
