

ARTICLES OF AMENDMENT
TO THE
CERTIFICATE OF INCORPORATION
OF

Pursuant to the provisions of Section 10-2A-113 of the Code of Alabama, the undersigned corporation adopts the following Articles of Amendment to its Certificate of Incorporation:

ARTICLE I

The name of the corporation is Sterile Technique, Inc.

ARTICLE II

The following amendment to the Certificate of Incorporation was adopted by the shareholders of the corporation on the 9th day of October, 1984, in the manner prescribed by the Alabama Business Corporation Act:

ARTICLE FIFTH of the Certificate of Incorporation is deleted in its entirety and the following is substituted in lieu thereof:

"FIFTH: The amount of the total authorized capital stock shall be 200 shares of common stock of the par value of \$10.00 per share."

ARTICLE III

The number of shares of the corporation outstanding at the time of such adoption was one hundred eleven (111); and the number of shares entitled to vote thereon was one hundred eleven (111). No shares were entitled to vote thereon as a class.


