VERIFIED STATEMENT OF CLAIM OF
MECHANIC'S AND MATERIALMAN'S LIEN

Billy Kirkland d/b/a Kirkland Building Services files this statement in writing, verified by the oath of Alan L. King, who has personal knowledge of the facts herein set forth:

That said Billy Kirkland d/b/a Kirkland Building Services claims a lien upon the following property, situated in Shelby County, Alabama, to-wit:

Southwest Quarter of the Northwest Quarter of Section 36, Township 19 South, Range 3 West, more particularly described as follows:

Commence at the Southwest corner of the Southwest Quarter of the Northwest Quarter of Section 36, Township 19 South, Range 3 West, thence Easterly along the South line of said Quarter-Quarter Section 1073.50 feet, thence 90 degrees 54' left northerly 239.58 feet to the point of beginning of tract of land herein described, thence continue along the last mentioned course 160.00 feet to the south Right-of-way boundary of a paved street, thence 80 degrees 01' left along said street 109.46 feet to the point of a curve to the left, said curve being subtended by a central angle of 26 degrees 23'30" and a radius of 238.82 feet, thence around the arc of said curve 110.0 feet, thence 81 degrees 01' left from tangent 174.17 feet, thence 82 degrees 34'30" left easterly 194.43 feet more or less to the point of beginning.

This lien is claimed, separately and severally, as to both the buildings and improvements thereon, and the said land.
