DEED OF CORRECTION

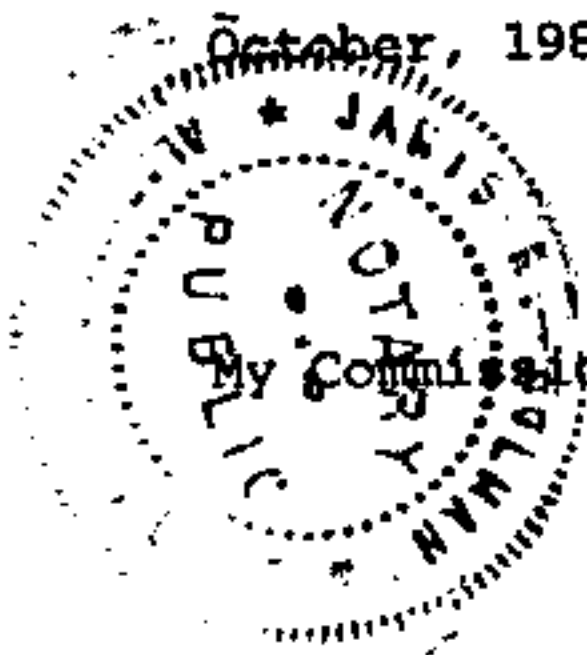
