CORRECTIVE RIGHT -OF- WAY

THE PURPOSE of this agreement is to more specifically describe the right-of-way conveyed in Real Volume 354, Page 778, originally conveyed to Billy Terrell McDanal, his heirs and assigns and being presently owned by Nelda Cofer Weaver.

WE, Charles William Vansant and wife, Nancy Gail Vansant owners of the land on which the hereinafter referred to Right of way is located, in consideration of Ten and 00/100 (\$10.00) Dollars and other valuable considerations, the receipt of which is hereby acknowledged, do hereby grant, bargain, sell and convey to Nelda Cofer Weaver a Right Of Way of 20 feet in width situated in Shelby County, Alabama more particularly described as follows:

An access road 20feet in width for the purpose of ingress and egress which is described as follows:

From the Northwest corner of the Southeast  $\frac{1}{4}$  of the Northwest  $\frac{1}{4}$  Section 17, Township 21 South, Range 1 East, run east for a distance of 10 feet along the north line of said  $\frac{1}{4}$ - $\frac{1}{4}$  section to the point of beginning of the centerline of said right -of-way and extend said centerline north to Alston Farm Road.  
All in Shelby County, Alabama.

THIS RIGHT-OF-WAY is for the benefit of the land or any portion thereof in the County of Shelby, State of Alabama, described as follows:

The South  $\frac{1}{2}$  of the Northeast  $\frac{1}{4}$  and the Southeast  $\frac{1}{4}$  of the Northwest  $\frac{1}{4}$  of Section 17, Township 21 South, Range 1 East.

THE SAID RIGHT-OF-WAY described herein is to and shall run with the land and shall be for the benefit and use of the Grantees herein, their heirs, executors, administrators and assigns.

Nelda Cofer Weaver hereby acknowledges that Charles William Vansant and wife, Nancy Gail Vansant do not maintain the right-of-way hereinabove described. It is also understood that this right-of-way shall also be used by the public in general and may be used for the purpose of carrying utilities to any residence.
