BEFORE ME, the undersigned, a Notary Public in and for said County and State, personally appeared LOU ALICE LUMPKIN, whose name is signed to this Affidavit and who is known to me and who being by me first duly sworn, doth depose and say as follows:

"My name is Lou Alice Lumpkin. I am eighty five years of age and reside in Birmingham, Alabama. I was a sister of Vivian Inez Coker. Both of us were born and raised in Jefferson County, Alabama. Sometime during the early 1920's my sister, Vivian Inez Coker married William Hollen Coker. They were married in Birmingham, Alabama. They were married during the year 1925. My sister and I were very close over many years. During the last twenty years of her life she and I lived together off and on. There was only one child born of the marriage of my sister, Vivian Inez Coker, and William Hollen Coker. The name of the child was William Vann Coker and he was born during the year 1928. William Hollen Coker died intestate in Jefferson County, Alabama, on April 1, 1955. His son, William Vann Coker, married Mary Clay Laxson, who was born in Huntsville, Alabama, but she was living in Birmingham at the time of their marriage. There was only one child born of this marriage, namely, Theresa Vann Coker, whose name is now Theresa Vann Anderson. William Vann Coker died intestate in Jefferson County, Alabama, on November 18, 1958, and his sole surviving heirs at law and next of kin were his mother, Vivian Inez Coker, his wife, Mary Clay Laxson Coker, and his daughter, Theresa Vann Coker. After the death of William Vann Coker, Mary Clay Laxson Coker married Robert Anderson, and he later adopted Theresa Vann Coker and her name became Theresa Vann Anderson.

My sister, Vivian Inez Coker, died intestate in Jefferson County, Alabama, on December 26, 1983, leaving no Last Will and Testament; however, there was administration on her estate in Jefferson County; and Wm. H. Johnston was appointed Administrator of her estate. The Petition shows that Theresa Vann Anderson is the sole surviving heir at law and next of kin of Vivian Inez Coker. There was no administration on the estate of my brother-in-law, William Hollen Coker, nor was there administration on the estate of his son, William Vann Coker, and my nephew. Of course, as stated above, both of them have been dead for many years, and I have never heard of any claims against their estates.
