This appointment is made under and by authority of the following provisions of the By-Laws of the company, which are now in full force and effect:

This Power of Attorney is signed and sealed by factimile under and by the authority of the following resolutions adopted by the Board (S) Rectors of CANXERS SURETY CORPORATION of Dallas, Texas at a meeting duly held on January 29, 1972

RESOLVED that the PRESIDENT, egg Vide President or Assistant Vice-President, in conjunction with the Secretary or any Assistant Secretary, may appoint attorneys to sect or secretary with authority as defined or limited in the instrument evidencing the appointment in each case for and on behalf of the company to execute and deliver and affix the seal of the company to bonds, undertakings, recognizances, and suretyship obligations believed kinds conditions may remove any such attorney-in-fact or agent and revoke any power of attorney previously granted to such person.

RESOLVED FURTHER that the signature of any authorized officer and the seal of the company may be affixed by facsimile to any power of attorney or certification thereof authorizing the execution and delivery of any bond, undertaking, recognizance, or other suretyship obligations of the company; and such signature and seal when so used shall have the same force and effect as though manually affixed.
