WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS, That in consideration of Fifteen Dollars (\$15.00) to the undersigned grantor in hand paid by the GRANTEEES herein, the receipt whereof is acknowledged I, LOLA DRIVER, A Widow, (Herein referred to as Grantor) do grant, bargain, sell and convey unto JAMES RUSSELL DRIVER and wife, BETTY ANN DRIVER (herein referred to as Grantees) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

One acre of land in the North  $\frac{1}{2}$  of the NW  $\frac{1}{4}$  of the SW  $\frac{1}{4}$  of Section 2, Township 24 North, Range 13 East, Shelby County, Alabama, described as follows:

Commence at the SW Corner of said North  $\frac{1}{2}$  of the NW  $\frac{1}{4}$  of the SW  $\frac{1}{4}$ ;

Thence run East along the South line of said twenty acres a distance of 130.0 feet, more or less to a point 270 feet

West of the centerline of Shelby County #224;

Thence continue last course a distance of 270.0 feet;

Thence run West a distance of 270.0 feet;




