That Doyle W. Strickland, d/b/a Strickland Construction Company, claims a lien on the following real property, to-wit:

Begin at the Northwest corner of SE 1/4 of SW 1/4 of Section 2, Township 24 North, Range 13 East and run thence south along the west line of said 1/4-1/4 Section a distance of 209 feet to the north line of property conveyed to Claude H. Jones as shown by Deed Book 307 Page 919 in Probate Office of Shelby County, Alabama; thence run east along said Claude H. Jones' north line a distance of 418 feet, more or less, to the west right-of-way line of U. S. Highway 31; thence run northerly along the west line of said U. S. Highway 31 to a point where the same intersects the North line of said 1/4-1/4 Section; thence run west along said North line of said 1/4-1/4 Section 420 feet, more or less, to the point of beginning.

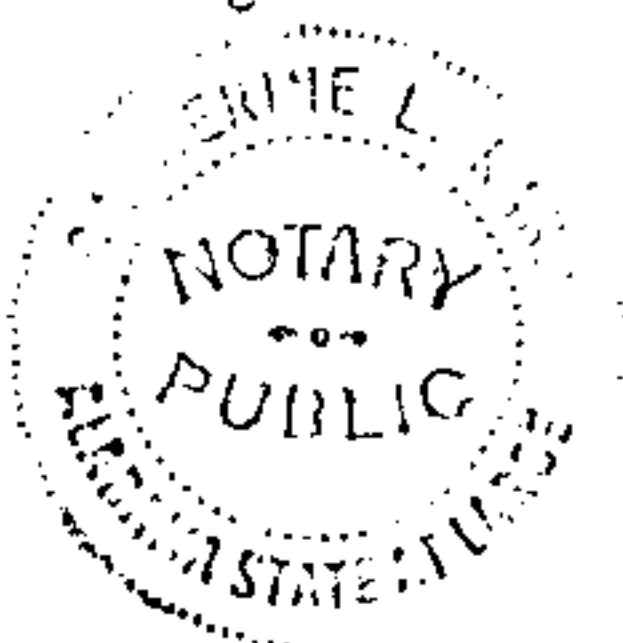
