Commence at the Southeast corner of Section 34, Township 21 South, Range 3 West, Shelby County, Alabama, thence run Northerly along the East line of said Section 34, a distance of 500.43' to the point of beginning of the property being described, Thence continue along last described course a distance of 329.0' to a point, Thence turn an angle of 90°-00' Left and run Westerly a distance of 659.17' to a point, Thence turn an angle of 88°-59'49" Left and run Southerly a distance of 329.05' to a point, Thence turn an angle of 91°-00'-11" Left and run Easterly a distance of 191.41' to a point, Thence turn an angle of 90°-00' Left and run Northerly a distance of 300.0' to a point, Thence turn an angle of 90°-00' Right and run Easterly a distance of 290.40' to a point, Thence turn an angle of 90°-00' Right and run Southerly a distance of 300.0' to a point, Thence turn an angle of 90°-00' Left and run Easterly a distance of 183.12' to the point of beginning, containing 3.00 acres.
